




Annually the Legion and Auxiliary Support the children of Cornville through the Cornville Community Easter Egg Hunt by donating funds for the purchase of two bikes.

Membership

As we prepare to head to the 2024 State Convention in Oro Valley Tucson 20 – 23 June and as the Post Adjutant, I'd be remiss in not submitting our post for a variety of awards. The department and National offers about 12 different



awards for both group and individual awards. Several of the awards are determined by the submission of the Consolidated Post Report (CPR) which is turned in once a year.

The way it works is that each post member (or auxiliary member) is asked to keep track of the "good deeds", that they do for others throughout the current year. Along with naming the deed we also need the hours spent and miles traveled and if it concerns a veteran or youth task. Many times these deeds are reoccurring, such as working at your church, delivering Meals on Wheels or any other task so it's just a matter of annotating your list rather than having to separately jotting it down. It may also include occasional acts such as taking a friend or neighbor on errands or doctor's appointment. The form will ask you for the time you spent, cost (if any) or miles. The miles are turned into dollar amounts which are added to any of your costs reported.

Once all the numbers are added up (and in the proper category) then they are reported to department where we get recognition for the deeds we've done. When The American Legion national commander testifies before Congress, the CPR data is used to provide numerical data of what the collective American Legion is doing. We report the hours, dollars and numbers of participants to show in quantifiable ways how our organization lives up to its motto of Veterans Strengthening America.

Reporting of the numbers continues to provide praise to our organization since they are collected by National Headquarters to help quantify – for Congress, American Legion media, national leadership and more – the good that American Legion posts do in their communities every year. National also provides recognition through their annual awards for outstanding service to our communities.

Sadly, most of our members (both auxiliary and post) fail to submit their deeds, say it's too much trouble or they don't do the act for recognition. In fact, according to national, nearly 65% of the posts don't report at all – you can be proud that your unit and post accomplishments are sent forward.

FYI - all of the Legion Family participates in this reporting the deeds they accomplish during the year, the auxiliary has a different form, but the same information to gathered! The 2023-2024 stats have been reported, but there's always next year so start saving your deeds NOW!



Service Officer Notes Jan Allbright

YOU HAVE BEEN DENIED!

You filled out all your paperwork, got supporting statements and



Statistics show that about 40% of all claim are denied for various reasons. About 80% of all claims that are filed without using a Service Officer are denied for various reasons. Currently there are three (3) paths for appeal. The first is a "De Nova Review" where "fresh eyes" review your claim and, hopefully, come to a different decision. The second is "New Data" where new and relevant medical data is discovered and the whole package gets a rereview. The third path is "Appeals" which is the VA version of the Supreme Court. This is a formal review process and can result is a "remand" (look at it all again), an "approval" (you win) or a "denial" (you lose). And at any point you can start the process over if you find new medical data.

Now come Rep. Mike Bost (R-III.) and Rep. Elise Stefanik (R-N.Y.) with two (2) new bills to assist and steam-line this process, Called the "Veterans Appeals Options Expansion Act" and the "Veterans Appeals Efficiency Act", these pieces of legislation propose several paths to updating the appeals process which is currently looking at something like 320,000 appeals currently in the back-log. We will be following this legislation closely and will keep you updated as it progresses thru the system.





The Auxiliary promotes the poppy as a symbol of the sacrifices our military have made, a symbol to open people's hearts and inspire them to donate. During the 2023 – 2024 membership year some of our poppy funds were donated to Wreath Across America for the purchase of wreaths for the Prescott VA cemetery and the District 8 Special Project which helped fund exercise equipment for veterans at the

Prescott VA hospital.

Like millions of American Legion Auxiliary poppies are distributed annually by ALA units, raising money for veterans, active duty servicemembers, and their families. Children are involved in spreading the poppy message, too. With the approval of the local schools, Poppy Poster Contests are held for students in grades 2 to 12. Additionally, the Little Miss Poppy Contest is a fun event for Junior Auxiliary members ages 6-12 who promote the Auxiliary memorial poppy.


